ACKNOWLEDGEMENT AND RELEASE FOR PARTICIPATION IN IN-PERSON ACTIVITIES

To the extent that it is permissible under applicable state and local orders related to the COVID-19 public health situation, REDEMPTION CHURCH is offering children the opportunity to participate in a variety of in-person activities. Participation in these in-person activities is completely optional. All in-person activities offered by REDEMPTION CHURCH, will, as detailed in separate communications to REDEMPTION CHURCH families, members, and attendees be conducted using guidelines aimed at protecting children, their families, volunteers, and staff against COVID-19-related risks.

This Acknowledgement and Release must be completed, signed, and dated, prior to participation in any in-person Redemption Kids activities.

By signing below, you specifically have read, understand, and agree to the following statements regarding the child you are allowing to participate in any in-person REDEMPTION CHURCH activities (referenced below as “Child”):

1. I recognize that most REDEMPTION CHURCH programs, by their nature, place children in close physical proximity to each other and to REDEMPTION CHURCH staff and volunteers, and, as such, present inherent risks of illness (including but not limited to influenza, COVID-19, Multisystem Inflammatory Syndrome in Children which is associated with COVID-19, and other communicable diseases) caused by exposure to airborne and surface-borne pathogens. I am fully aware of the foregoing risks and hazards to Child presented by his/her participating in such programs. I KNOWINGLY AND VOLUNTARILY ASSUME ALL SUCH RISKS, EVEN IF ARISING FROM THE NEGLIGENCE OF THOSE PERSONS AND ENTITIES RELEASED FROM LIABILITY BELOW, AND I ACCEPT AND ASSUME FULL RESPONSIBILITY FOR ANY AND ALL INJURIES AND ILLNESSES TO CHILD THAT MAY ARISE AS A RESULT OF PARTICIPATING IN ANY REDEMPTION CHURCH PROGRAM.

2. I understand that it is my responsibility to consult with a physician prior to Child's participation in any REDEMPTION CHURCH program to determine the appropriateness of Child's participation. I represent and warrant that Child is physically healthy and does not have any illness or medical condition(s) that would prevent his/her participation in REDEMPTION CHURCH programs. I acknowledge that REDEMPTION CHURCH has not and will not render any medical services to Child, including but not limited to medical diagnosis or treatment of any physical condition, injury, or illness.

3. I understand that REDEMPTION CHURCH does not carry medical insurance for Child. I agree to maintain sufficient medical insurance and to pay all costs associated with any injuries and illnesses that may occur as a result of Child's participation in REDEMPTION CHURCH programs.

4. IN CONSIDERATION OF CHILD BEING PERMITTED TO PARTICIPATE IN REDEMPTION CHURCH PROGRAMS, I, ON BEHALF OF CHILD, MYSELF, CHILD'S OTHER PARENT AND GUARDIAN(S) (IF ANY), AND OUR RESPECTIVE HEIRS AND ASSIGNS (THE “RELEASORS”), HEREBY HOLD HARMLESS, WAIVE, AND RELEASE REDEMPTION CHURCH AND ALL ITS OWNERS, OFFICERS, DIRECTORS,

REPRESENTATIVES, EMPLOYEES, AGENTS, VENDORS, CONTRACTORS, VOLUNTEERS, INSURERS, SUCCESSORS, AND ASSIGNS (COLLECTIVELY, THE "RELEASEES") FROM AND AGAINST ANY AND ALL LIABILITY, CLAIMS, ACTIONS, AND CAUSES OF ACTION, WHETHER KNOWN OR UNKNOWN, WHETHER NOW EXISTING OR ACCRUING IN THE FUTURE, ON ACCOUNT OF PERSONAL INJURY, ILLNESS, DEATH, PROPERTY DAMAGE, OR OTHER LOSS ARISING OUT OF OR RELATED IN ANY WAY TO CHILD'S PARTICIPATION IN REDEMPTION CHURCH PROGRAMS. THIS RELEASE SPECIFICALLY INCLUDES INJURY, ILLNESS, DEATH, PROPERTY DAMAGE, AND OTHER LOSS CAUSED BY THE NEGLIGENCE OF REDEMPTION CHURCH AND/OR OTHER RELEASEE(S), BUT EXCLUDES INJURY, ILLNESS, DEATH, PROPERTY DAMAGE, AND OTHER LOSS CAUSED BY THE GROSS NEGLIGENCE OR WILLFULL OR WANTON MISCONDUCT OF REDEMPTION CHURCH AND/OR OTHER RELEASEE(S). WE COVENANT THAT NEITHER I, NOR CHILD, NOR THE OTHER RELEASORS WILL MAKE OR BRING ANY SUCH CLAIM AGAINST REDEMPTION CHURCH OR ANY OTHER RELEASEE, AND WE FOREVER RELEASE AND DISCHARGE REDEMPTION CHURCH AND ALL OTHER RELEASEES FROM LIABILITY UNDER SUCH CLAIMS.

5. I warrant and agree that I am the parent or legal guardian of Child, that I have the legal right to consent to this Acknowledgement and Release on behalf of Child, myself, Child's other parent and guardian(s), if any, and our heirs and assigns; and that by signing below, we hereby do consent to the terms and conditions of this Acknowledgment and Release.
